Retiring Director of Foundation & Friends of the Botanic Gardens

After 12 years of service, Katrina Horrobin's final term as a Director comes to an end at this year's AGM. For many years Kate has filled the leadership roles of Deputy Chair of the Board and Chair of the Nominations and Remuneration Committee. She has been an astute, collaborative and much-admired colleague, and will be missed.

Appointment of new Director

Kate's departure means there will be one vacancy on the Board at the date of the AGM. The Board has received and reviewed recommendations from the Nominations and Remuneration Committee for the vacant position.

On the committee's recommendation, the Board is pleased to support Paul Thorley as our preferred candidate to fill the vacant position. Paul is currently serving as the interim Executive Director (the position known in previous years as CEO) of Foundation & Friends. Some background on Paul and his contribution to the Gardens is attached at the end of these papers.

Under our Constitution, the Executive Director of the Foundation & Friends cannot be a serving Elected Director. Therefore, the Board will appoint Paul to the vacant Director position when he steps down as Executive Director in the new year.

Our search for a permanent Executive Director is well under way and we will update members at the AGM.

Increase in number of Elected Directors

The Board is proposing an increase of the number of Elected Directors of Foundation & Friends from eight (as it is currently) to ten.

As part of a review this year of our philanthropy activities, it was agreed that the Board would benefit from deeper relationships with Sydney's community of large philanthropic donors. Priority in our search to fill the two new Board positions next year, if those positions are approved at this year's AGM, will be given to candidates with a history of substantial philanthropic activity, and/or deep networks in the philanthropic community.

Information on candidate nominated to fill the vacant Director's position

Paul Thorley is currently the interim Executive Director of Foundation & Friends. Prior to taking up that position in December 2024, Paul was an active volunteer in Growing Friends for almost 2 years and is a longtime member of our organisation. He was CEO/COO for Capgemini Asia Pacific (APAC) and the UK for just under 20 years. As the led consultant he transformed many companies throughout Australia and Asia. As the CEO of Capgemini he grew profitable operations in nine APAC countries with over 10,000 staff. Since moving with his family to Australia in 2002, he has supported many conservation and education initiatives. At UTS Business School, he became an Adjunct Professor and subsequently chaired a major new Aged Care multi faculty and fundraising program.
